# Additional information on video surveillance



The protection of your personal data is an important concern for us. That is why we operate our video surveillance systems in accordance with the applicable legislation on the protection of personal data and data security.

## 1. Information about the operator

#### 2. Processed data categories

In the context of video surveillance, we process the following personal data:

- optical video recordings of the company premises, including the entrance and the immediately adjacent outdoor area (a sound recording does not takes place) as well as
- date and time of recordings.

# 3. Legal basis for processing / purpose of processing

The legal basis for data processing is "the protection of legitimate interests" of our company according to Article 6 (1) (f) GDPR.

We process your personal data for the following purposes:

- to prevent, detect and investigate criminal offences (such as theft and vandalism);
- to be able to exercise our domiciliary rights
- and to prevent, detect and clarify unauthorized access to the company premises.

#### 4. Transmission and disclosure of personal data

We transfer your personal data to:

- other G+D Group companies, if this is necessary to fulfil the above-mentioned purposes,
- to courts, arbitral tribunals, authorities or legal advisers where this is necessary to comply with applicable law
- to assert, exercise or defend legal claims, insofar as this is necessary.

### **5.** Storage period

Video recordings are generally deleted within 30 days. A longer storage takes place only in individual cases, if a longer storage for the purpose mentioned for the examination and evaluation of the video recordings is necessary (e.g. if there is a reasonable suspicion of a criminal offence and the investigation and evaluation of the video recording is necessary in the course of an investigation). In this case, the video recordings will be deleted after the investigation is complete.

### 6. Your Rights

Under applicable data protection law, you may have the right to:

- to request the restriction of the processing of personal data,
- to request the transfer of data, or
